To receive a distribution, you must have been a registered shareholder of a Fund on the indicated record date(s). Distributions were paid to shareholders on the payment date(s). Past distributions are not indicative of future distributions. Transactions in shares of the Funds will also generate tax consequences and transaction expenses.

For individuals and other non-corporate shareholders, the portion of a Fund distribution characterized as "Qualified Dividend Income" may be subject to a maximum tax rate of 15% through 2010. However, a shareholder will qualify for this reduced tax rate with respect to distributions reported by a Fund as Qualified Dividend Income only if the shareholder meets a holding period requirement with respect to its shares in the Fund (generally, a shareholder must have held the shares for 61 days out of the 121-day period beginning 60 days before the Fund's ex-dividend date). The amount(s) shown as "QDI%" is the amount of each Fund's Qualified Dividend Income expressed as a percentage of that Fund's total dividend income. The amount(s) shown as "Foreign Taxes Paid" is, in general, the per share amount of taxes paid or accrued by each Fund to a foreign country or U.S. possession. The amount shown as "Qualified Foreign Taxes Paid", subject to certain limitations, may be claimed for Federal income tax purposes as a foreign tax credit or may be deducted as an itemized deduction. Non-U.S. shareholders generally will not be subject to United States income or withholding tax on the amount shown as "Qualified Short-Term Capital Gain" for any Fund.
