

Fund Overview

The WisdomTree U.S. SmallCap Dividend Fund seeks to track the investment results of dividend-paying small-cap companies in the U.S. equity market.

Formerly known as WisdomTree SmallCap Dividend Fund through June 29, 2017.

Index Description

The WisdomTree U.S. SmallCap Dividend Index is a fundamentally weighted index measuring the performance of the small-capitalization segment of the US dividend-paying market. Prior to June 30, 2017, the WisdomTree U.S. SmallCap Dividend Index was named the WisdomTree SmallCap Dividend Index.
