The WisdomTree U.S. Earnings 500 Fund seeks to track the investment results of earnings-generating large-cap companies in the U.S. equity market.

Formerly known as WisdomTree Earnings 500 Fund through June 29, 2017.

Index Description

The WisdomTree U.S. Earnings 500 Index is a fundamentally weighted index that measures the performance of earnings-generating companies within the large-capitalization segment of the U.S. Stock Market. Prior to June 30, 2017, the WisdomTree U.S. Earnings 500 Index was named the WisdomTree Earnings 500 Index.
