The WisdomTree International ESG Fund (RESD)* seeks to achieve its investment objective of capital appreciation by integrating factor-based investing with developed market international companies who screen favorably on environmental, social and governance (ESG) characteristics.

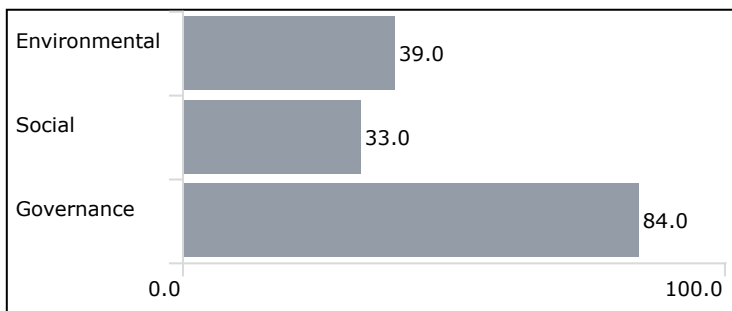

Why RESD?

- Designed to provide broad-based exposure to developed market international companies with greater weighting to companies that align with ESG characteristics
- Combines the societal benefits of ESG with potential outperformance of an actively managed, factor-based approach
- Seek to boost exposure to higher rated ESG companies while limiting tracking error

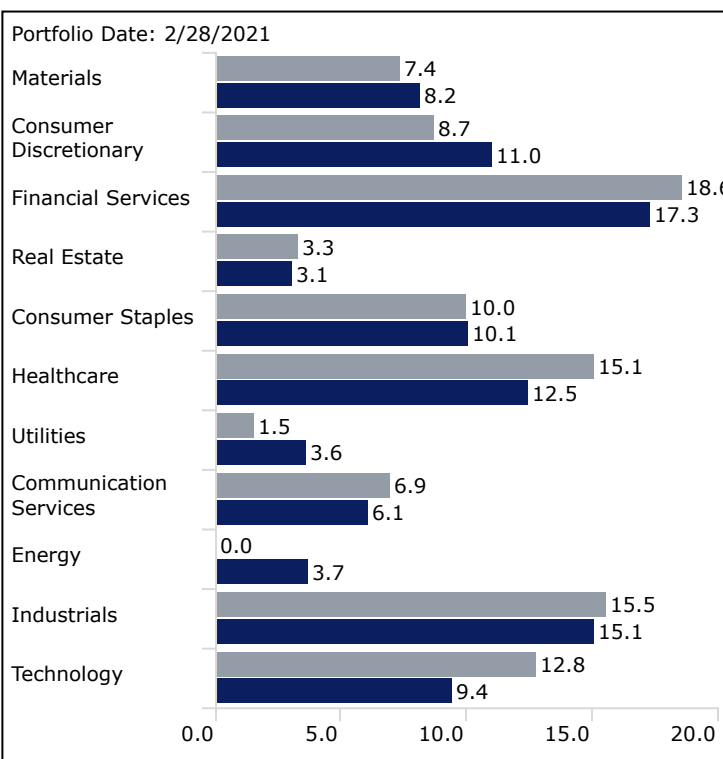
% Rank Within Category

Lower % rank indicates more favorable ESG characteristics relative to peers



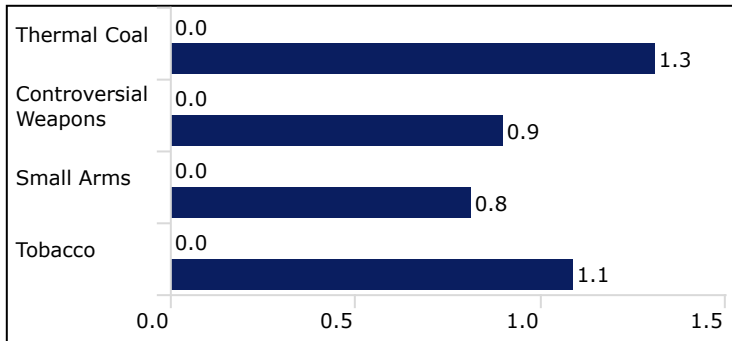
Sector Exposure

Legend: RESD (light grey), MSCI EAFE Index (dark blue)



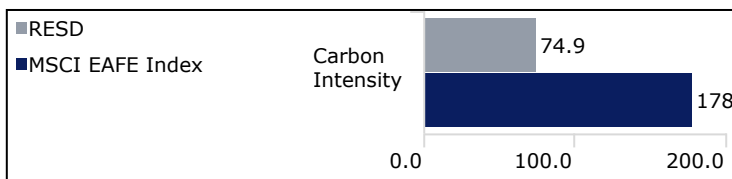
Portfolio Product Involvement (%)

Legend: RESD (light grey), MSCI EAFE Index (dark blue)



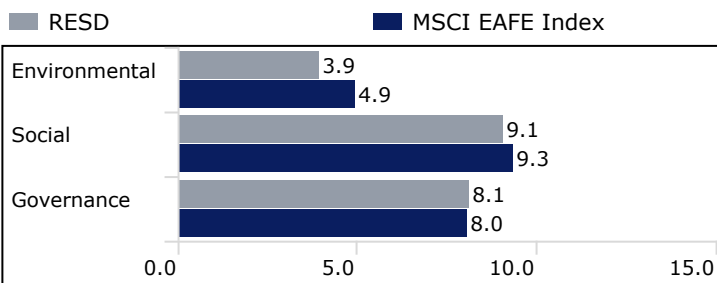
Carbon Intensity

Definitions

ESG Scores: The asset weighted average of the company environmental risk, social risk, and governance risk scores for the covered holdings in a portfolio. Environmental criteria consider how a company performs as a steward of nature. Social criteria examine how it manages relationships with employees, suppliers, customers, and the communities where it operates. Governance deals with a company's leadership, executive pay, audits, internal controls, and shareholder rights. These scores measure the degree to which a company's economic value may be at risk driven by environmental, social, and governance factors and represent the unmanaged risk exposure after taking into account a company's management of such risks. The environmental risk, social risk, and governance risk scores are displayed as a number between 0 and 100, though most scores range between 0 and 25.

% Rank in Category: A portfolio's percent rank within its Morningstar Global Category, based on the output of the ESG scoring approach described above. The Morningstar Global Category is a global system of peer groups for managed portfolios based on investment strategy without regard to the region where the strategy is available for sale. The % Rank in Category data is a point-in-time value reflecting the fund's rank as of the date indicated in the table above.

Portfolio Product Involvement: To calculate portfolio product involvement, Morningstar establishes a minimum involvement threshold for each product area. Holdings that meet the minimum involvement threshold are summed by their weight in the portfolio. The sum represents the portfolio's asset-weighted exposure to the product involvement area without an adjustment for cash.

Carbon Intensity: The asset-weighted average of holdings with actual emissions data from the Carbon Disclosure Project or estimated values from Sustainalytics, a leading provider of ESG research, in a portfolio. Carbon Intensity is computed for each holding as follows: Total Emissions (metric tons of Co2) / Revenue (Mil USD), and aggregated at the fund level.

All underlying company-level data is produced by Sustainalytics. All ESG data represented in this document are point-in-time values reflecting the ESG characteristics of the holdings as of the date indicated above.
