**Description of Activity**

- Visually checked one bar from each pallet for the bar number, brand and purity;
- Reconciled the physical movement of bars which occurred during the inspection period between 1 January 2025 and 18 February 2025.

**Non-conformities**

There were no administrative non-conformities identified in respect of the silver bars during the audit.
