THIS SUPPLEMENTAL TRUST DEED is dated 3 September 2019 and made

BETWEEN:

- (1) **BOOST ISSUER PUBLIC LIMITED COMPANY**, a company incorporated under the laws of Ireland under company number 515981 and having its registered office at 2 Grand Canal Square, Grand Canal Harbour, Dublin, Ireland (the "**Issuer**");
- (2) **BOOST MANAGEMENT LIMITED**, (which expression shall, where the context admits, include any successor Manager appointed by the Issuer), of Ordnance House, 31 Pier Road, St Helier, Jersey JE4 8PW (the "**Manager**"); and
- (3) **THE LAW DEBENTURE TRUST CORPORATION P.L.C.**, a company incorporated under the laws of England with registered number 1675231, whose registered office is at Fifth Floor, 100 Wood Street, London EC2V 7EX, England (the "**Trustee**", which expression shall, wherever the context so admits, include such company and all other persons or companies for the time being the trustee or trustees of these presents) as trustee for the ETP Securityholders,

each being a "party" and together the "parties".

WHEREAS:

- (A) The Issuer, the Manager and the Trustee have entered into a trust deed dated 30 November 2012 (the "**Master Trust Deed**") as amended by a first supplemental trust deed dated 22 November 2013, a second supplemental trust deed dated 24 October 2016 and a third supplemental trust deed dated 31 July 2019, each between the same parties (the Master Trust Deed as so amended, the "**Trust Deed**").
- (B) The Master Trust Deed incorporates the definitions set out in a master definitions schedule dated 30 November 2012 (the "**Master Definitions Schedule**"), the terms of which are deemed to apply separately to each agreement, instrument or deed in which it is specified that the Master Definitions Schedule is incorporated (including the Trust Deed) and shall apply as modified or supplemented by the provisions of such agreement, instrument or deed.
- (C) This Supplemental Trust Deed is supplemental to the Trust Deed.
- (D) The Issuer is proposing to change its name by special resolution and by amending its constitution to "WisdomTree Multi Asset Issuer Public Limited Company". Such change of name will become effective on the issue by the registrar of companies in Ireland of a certificate to that effect. In addition to its proposed change of name, the Issuer is proposing that the name of certain types of ETP Securities be changed and to make certain consequential and other changes to the Trust Deed and the terms and conditions of the ETP Securities issued under the Programme (the "**Conditions**").
- (E) On or about the date of this Supplemental Trust Deed, the Issuer has also updated the prospectus in respect of the Programme and proposes to make certain consequential changes to the Conditions in connection with such update.
- (F) Pursuant to Clause 15.1(i) of the Master Trust Deed, and Condition 15.2(A)(i) of the Conditions, the Trustee may agree to modify the Trust Deed and Conditions

without the consent of the ETP Securityholders if, in the opinion of the Trustee, the modification is of a formal, minor or technical nature.

- (G) The Issuer and Trustee have agreed pursuant to the third supplemental trust deed dated 31 July 2019 to amend the Trust Deed (including certain terms incorporated into the Trust Deed from the Master Definitions Schedule) in order to make changes (with effect from the Effective Date) relating to the changes referred to in Recital (D).
- (H) In view of the amendments referred to in Recitals (E) and (G), the Issuer has now determined to make corresponding amendments to the Conditions pursuant to this Supplemental Trust Deed in order to make changes which are of a formal, minor or technical nature and the Trustee has given its consent to the same pursuant to the Trustee's powers referred to in Recital (F), in each case in the manner hereinafter appearing.
- (I) The Trustee and the Issuer are of the opinion that the changes being effected by this Supplemental Trust Deed, are for the purposes of Clause 15.1(i) of the Master Trust Deed and Condition 15.2(A)(i), of a formal, minor or technical nature.
- (J) The Issuer and the Trustee intend that this Supplemental Trust Deed shall constitute a written amendment of the terms of the Trust Deed and the written consent of the Trustee to such amendments.

NOW THIS SUPPLEMENTAL TRUST DEED WITNESSES and it is hereby agreed and declared as follows:

1. Definitions

1.1 All words and expressions defined in the Trust Deed shall unless otherwise stated have the same meanings in this Supplemental Trust Deed.

1.2 In this Supplemental Trust Deed, the following expression shall have the following meaning:

Effective Date: 26 September 2019.

Update Effective Date: 03 September 2019

1.3 Clauses 1.2 to 1.6 of the Master Trust Deed apply to this Supplemental Trust Deed.

2. Amendments to the Conditions

2.1 With effect from the Update Effective Date the Conditions (as set out in Schedule 6 of the Master Trust Deed) are amended as follows:

2.1.1 all references to "Link IFS Limited" shall be read as references to "Apex IFS Limited";

2.1.2 all references to "Link Trustee Services (Jersey) Limited" shall be read as references to "Apex Financial Services (Trustees) Limited";

2.1.3 all references to "Prospectus Directive" shall be read as references to "2017 Prospectus Regulation"; and

- 2.1.4 the definition of "Prospectus Directive" in Condition 1.1 shall be deleted in its entirety and replaced with the following:
- “**2017 Prospectus Regulation**” means Regulation (EU) 2017/1129 of the European Parliament and of the Council of 14 June 2017.”
- 2.2 With effect from the Effective Date the Conditions (as set out in Schedule 6 of the Master Trust Deed and amended pursuant to Clause 2.1 above) are amended as follows:
- 2.2.1 in the first paragraph, the words “which was amended and supplemented by a first master trust deed supplement dated 22 November 2013 and a second master trust deed supplement dated 24 October 2016 between the Issuer, the Manager and the Trustee (as further amended, supplemented, novated and/or replaced from time to time, the “**Master Trust Deed**”).” shall be deleted and replaced by the following words:
- “which was amended and supplemented by a first master trust deed supplement dated 22 November 2013, a second master trust deed supplement dated 24 October 2016, a third master trust deed supplement dated 31 July 2019 and a fourth master trust deed supplement dated 3 September 2019, each between the Issuer, the Manager and the Trustee (as further amended, supplemented, novated and/or replaced from time to time, the “**Master Trust Deed**”);
- 2.2.2 all references in the Conditions to “Boost Issuer Public Limited Company” shall be read as references to “WisdomTree Multi Asset Issuer Public Limited Company”;
- 2.2.3 all references in the Conditions to “Boost Management Limited” shall be read as references to “WisdomTree Multi Asset Management Limited”;
- 2.2.4 the definition of “Issuer’s Website” in Condition 1.1 shall be amended by including the words “internet address: <http://www.wisdomtree.eu>” in place of “internet address: <http://boostetp.com>”; and
- 2.2.5 the definition of “Manager” in Condition 1.1 shall be amended by including the words “WisdomTree Multi Asset Management Limited” in place of “Boost Management Limited”.
- 2.3 With effect from the Effective Date, the names of each of the ETP Securities listed in the Annex of this Supplemental Trust Deed (such names being specified in item 1 (*Class of ETP Securities to which these Final Terms apply*) of the applicable Final Terms, which forms part of the Conditions of such ETP Securities) shall be amended, from the name specified under “Current Name” in the Annex to the corresponding name specified under “New Name” in the Annex.
- 2.4 In accordance with Clause 15.1(i) of the Master Trust Deed and Condition 15.2(A)(1)(i), the Trustee confirms that it is of the opinion that the amendments to the Conditions made herein are of a formal, minor or technical nature.

3. Publication of Notices

The Issuer hereby confirms it has notified the ETP Securityholders by a RIS announcement on 31 July 2019 of (i) its proposed change of name; and (ii) the proposed change of name of the ETP Securities of each class.

4. Governing Law and Submission to Jurisdiction

This Supplemental Trust Deed shall be governed by and construed in accordance with the laws of England. Each of the parties hereby submit to the non-exclusive jurisdiction of England in respect of any dispute arising out of or in connection with this Supplemental Trust Deed, including any question regarding its existence, validity or termination, or the legal relationships established by this Supplemental Trust Deed. Clause 22 of the Master Trust Deed shall apply to this Supplemental Trust Deed as it does to the Master Trust Deed.

5. Construction

- 5.1 The Trust Deed shall henceforth be read and construed in conjunction with this Supplemental Trust Deed.
- 5.2 A memorandum of this Supplemental Trust Deed shall be endorsed by the Trustee on the Master Trust Deed and by the Issuer on the duplicate thereof.
