

Investment Philosophy

WisdomTree model portfolios implement an index-centric approach, seeking to add value through both asset allocation and ETF selection relative to composite cap-weighted benchmarks. While the models are strategic in nature, they also reflect dynamic tilts based on market conditions. By incorporating ETFs that provide representative exposure and rebalancing back to measures of relative value, WisdomTree seeks to increase absolute and risk-adjusted returns compared to traditional approaches that predominantly use market-cap weighted funds.

Strategy Description

The WisdomTree Efficient Core Model Portfolios are designed for investors seeking to incorporate “non-traditional” or alternative funds—strategies that historically have lower correlation to stocks and bonds—into a traditional portfolio using ETFs. Efficient Core references a capital efficient combination of stocks and bond futures that free up room in a portfolio to incorporate non-traditional and diversifying investments. The models may use both WisdomTree and non-WisdomTree ETFs. They typically include U.S. and international equity and fixed income funds, and alternative strategies which seek to provide diversification and mitigate against inflation and other asset allocations risks. For performance purposes, this strategy will be benchmarked to a combination of a broad-based global equity benchmark and a U.S. aggregate bond index.
