The ex-dividend date is the day on which all shares bought and sold no longer come attached with the right to be paid the most recently declared dividend. It is also on this date that an amount roughly equal to the dividend paid is removed from the Fund's net asset value once declared. Total Return Market Price is calculated based on the midpoint of the bid/ask spread on payable date. The payable date is the date the dividend is paid to the holders of record. For the current performance reporting period, the ex-dividend date occurred prior to the reporting period and the payable occurred during the reporting period.
