Each month the DTI Index sector exposure is rebalanced back to the fixed weights, 50% physical commodities and 50% financials when energy is long and approximately 39.5% commodities and 60.5% financials when energy is sector are positioned either long or short depending on the current market environment. The DTI Index individual market components, sectors and related weightings, as well as other aspects of the calculation of the DTI Index are subject to change at any time.

The BofA Merrill Lynch Global Diversified Inflation-Linked Index tracks the total return performance of a broad, capped market value weighted index designed to measure the performance of inflation-linked sovereign debt publicly issued and denominated in the issuer's own domestic market and currency. Constituent securities for selected countries are rebalanced monthly. The "hedged" version of this index completely hedges the index's foreign currency exposures using forward currency contracts. Each currency in the basket and its weight is determined annually based on its share of international trade and foreign exchange (FX) liquidity.

The <u>BofA Merrill Lynch 0-5 Year US High Yield Constrained, Zero Duration Index</u> tracks the performance of the combination of a long position in short maturity US high yield bonds and a short position in on the run US Treasuries where the net interest rate exposure of the index is adjusted to a zero year duration. Market values of long and short positions are rebalanced at month-end. The <u>BofA Merrill Lynch 0-5 Year US High Yield Constrained, Negative Seven Duration Index</u> tracks the performance of the combination of a long position in short maturity US high yield bonds and a short position in on the run US Treasuries where the net interest rate exposure of the index is adjusted to a negative seven par duration. Market values of long and short positions are rebalanced at month-end. Japanese Government includes fixed income securities issued by the Japanese government, but issued by other entities are excluded from the index as well as inflation linked bonds issued by Japan. Qualifying securities must have a fixed coupon schedule and a minimum amount outstanding JPY 20 billion.

The <u>Bloomberg US Treasury Floating Rate Bond Index</u> is a rules-based, market-value weighted index engineered to measure the performance and characteristics of floating rate coupon U.S. Treasuries which have a maturity greater than 12 months. To be included in the index a security must have a minimum par amount of 1,000MM.

MSCI EAFE Small Cap Local Index is a free float-adjusted market capitalization equity index that is designed to measure the performance of small-cap stocks within the developed equity market, excluding the U.S. and Canada, in local currency.
