

The WisdomTree Emerging Markets Corporate Bond Fund seeks to provide a high level of total return consisting of both income and capital appreciation through investments in the debt of emerging markets corporate issuers.

The Fund generated a net return of 1.61% on net asset value (NAV) during the second quarter, underperforming its reference benchmark, the JPMorgan Corporate Emerging Markets Bond Index Broad by 7 basis points (1.61% versus 1.68%). Excluding fees, the Fund outperformed the index by 7bp.


Country Selection (+1.6bp) did not meaningfully impact performance. The strategy's large underweight to the Asian countries such as Hong Kong, Singapore, and South Korea had a positive impact on relative performance as higher quality Asian countries generally underperformed during the quarter. The strategy's large overweights to Mexico and Russia contributed as both countries outperformed the benchmark. Underweights to Venezuela and Ukraine detracted from relative performance as these markets performed well through the end of the year.

Sector Selection (-2.4bp) had a slight negative impact on performance. The overweight to Mexican industrials helped but overweight to metals & mining detracted. In Brazil, overweights to metals & mining helped while the underweight to consumers hurt performance.

Security Selection (+8.0bp) contributed the most to performance during the quarter. Brasil Telecom did very well, while Mexico's Grupo Bimbo underperformed other consumer issuers in the same sector.

The JPMorgan Corporate Emerging Markets Bond Index Broad is a market capitalization weighted index consisting of US dollar-denominated Emerging Market corporate bonds. The index serves as a global corporate benchmark representing Asia, Latin America, Europe and Middle East / Africa. US dollar-denominated corporate issues from index-eligible countries are narrowed further by only including issues with more than \$300m current face outstanding and at least five years to maturity (at the time of inclusion into the index). A basis point is defined as one one-hundredth of a percent.
