

The WisdomTree Emerging Markets Corporate Bond Fund seeks to provide a high level of total return consisting of both income and capital appreciation through investments in the debt of emerging markets corporate issuers.

The Fund generated a net return of 3.31% on net asset value (NAV) during the fourth quarter. The Fund outperformed its reference benchmark, the JPMorgan Corporate Emerging Markets Bond Index Broad by 46 basis points (3.31% versus 2.85%). Since inception (March 8th, 2012), the Fund has generated excess returns of 154 basis points when compared to its benchmark.

The Fund's overweight exposure to Venezuelan corporate issuers combined with its underweight to companies domiciled in South Korea and Hong Kong boosted performance relative to the index during the quarter. Sector tilts away from Mexican Telecom added to relative performance as the sector underperformed this quarter. In addition, the overweight allocation to Indian Metals & Mining contributed to sector outperformance. Security selection underperformed during the quarter. The Mexican issuers Grupo Bimbo (2.45%, Consumer Products) and Petroleos Mexicanos (6.91%, Oil & Gas) were significant detractors over the period. Issue selection in Brazil's Oil & Gas as well as Metals & Mining Sectors also took away from performance last quarter.


In the absence of lasting, structural solutions to global macroeconomic issues, namely - the Euro zone debt crisis, Chinese growth concerns, and the U.S. recovery, the emerging world could continue to see divergent performances at the individual country level.

As many Emerging Market central banks have already reduced official interest rates to impart a greater emphasis on weak global growth, the expectation is for them to maintain a cautious stance with respect to monetary and exchange rate policy over the coming quarter. Although inflation has been at very manageable levels, supporting growth without fueling inflation will remain a challenge given heightened global central bank activism and geopolitical risk.

Oil & Gas and Metals & Mining remain favored sectors, with many top-tier emerging market Oil & Gas names representing less cyclical exposure to the broad market. Select Telecom and Utility companies in Brazil, Colombia, Indonesia, Mexico and Russia remain overweights. We expect to continue to run a large underweight to the Banking & Finance sector on the back of growing asset quality concerns and generally weaker global economic conditions.

The JPMorgan Corporate Emerging Markets Bond Index Broad is a market capitalization weighted index consisting of US dollar-denominated Emerging Market corporate bonds. The index serves as a global corporate benchmark representing Asia, Latin America, Europe and Middle East / Africa. US dollar-denominated corporate issues from index-eligible countries are narrowed further by only including issues with more than \$300m current face outstanding and at least five years to maturity (at the time of inclusion into the index). A basis point is defined as one one-hundredth of a percent.
